

Official Rules and Regulations of the  
2018 Kiwanis Incredible Duck Splash

Presented by the Kiwanis Clubs of Columbus, the "Presenter", a 501c (4) (Tax Exempt Charity) Tax I.D. #35-6059140, Indiana Gaming License # 146962

1. A maximum of 17,000 rubber ducks will be entered in the raffle.
2. Ducks will be released into Round Lake in Mill Race Park beginning at approximately 12:30 p.m. on October 13, 2018.
3. The cost to adopt duck(s) is as follows: \$5 per duck, or \$20/5 ducks, \$50/13 ducks, \$75/20 ducks and \$100/30 ducks.
4. All ducks entered will be provided by and shall remain the property of the Presenter and will be numbered consecutively .
5. Ducks may only be adopted from Kiwanis members or approved non-profit tax-exempt charities using the official Kiwanis Incredible Duck Splash adoption form, with a pre-printed serial number, provided by the Presenter. The adopter may adopt from 1 to 30 ducks on a single adoption form.
6. Each duck participating in the raffle has a number printed on it to identify the duck. One duck number will be randomly assigned by our computerized tracking software, prior to the raffle, for each duck adoption indicated on the official Kiwanis Incredible Duck Splash adoption form.
7. Ducks will be randomly drawn from the lake and will be placed in a tube constructed of PVC pipe as they are drawn. All prizes will be awarded based on the order the ducks are withdrawn from the lake, with the first duck drawn winning first prize, second drawn winning second prize, and so on.
8. One number corresponding to one of the ducks entered into the raffle will be electronically selected by Interactive Promotions Group prior to the drawing. If the number from one of the first 10 ducks drawn matches this number, the person's entry that corresponds to that duck number will win their choice of a new vehicle or \$50,000.\*
9. The Presenter reserves the right at its sole discretion, to substitute prizes of comparable value.
10. The entry portion of each official Kiwanis Incredible Duck Splash adoption form must be filled out completely and legibly and received by Presenter prior to the start of the raffle on October 13, 2018 to be eligible to win any prize. Entrants assume the risk of non-delivery of any entries to Presenter.
11. Members of The Kiwanis Incredible Duck Splash committee and their immediate family members are not eligible to win. Adopters must be at least 18 years of age.
12. Winners will be announced at the event. **Winners need not be present to win.** All winners will be notified by U.S. mail or telephone if not immediately available. If any raffle winner does not claim his/her prize from the Presenter within 30 days after October 13, 2018, Presenter will select winners through a random drawing of remaining entries. All prizes will be awarded.\*\* A list of winners may be obtained by sending a self-addressed stamped envelope to Meridian Kiwanis Club, P.O. 13. Cash equivalent prizes may be provided in lieu of the designated prizes at the sole discretion of the Presenter. Any and all taxes and fees, including, but not limited to applicable license and registration fees on any vehicles, are the sole responsibility of the winner.
14. By entering, entrants release Presenter and its officers, directors, committee members, and any other related entities from any and all liability with respect to prizes.
15. By entering, a winner consents to the promotional use of their names and likeness without additional compensation.
16. Chances of winning depend on the total number of qualified entries.
17. This event is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
18. All decisions and interpretations of rules and regulations and determination of winners will be made by the Presenter and its judgment is final.

\*New Vehicle: The Kiwanis clubs of Columbus are only the underwriter of the premium for the insurance policy covering delivery of the new vehicle and are not responsible for any failure on the part of the Insurer to perform should there be a winner.

\*\*New vehicle or \$50,000 prize will only be awarded as described in paragraph 8 above. The person owning the "Lucky Duck" number will receive a consolation prize of \$100 cash if their duck is not one of the first 10 ducks drawn.
